## Cleansing Notice / Appendix 2A

### Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

**Los Cerros Limited (ASX: LCL) ("Los Cerros" or the "Company")** is pleased to advise that it has issued and allotted 14,814,860 fully paid ordinary shares ("**Placement**" shares) under Listing Rule 7.1 as part one of the first tranche of the placement to sophisticated investors as announced to the market on 5 February 2020.

    1. The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    2. The rights and liabilities attaching to the Securities.
