Issue of Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the "Company") advises that it has issued and allotted 187,500 fully paid ordinary shares ("Shares") upon the exercise of 187,500 unquoted options exercisable at \$0.10 per option on or before 6 April 2022.

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the shares issued pursuant to the exercise of options ("**Shares**") and noted in the attached Appendix 2A will fall within the exemption in section 708A(5) of the Act.

 - 1. The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - 2. The rights and liabilities attaching to the Securities.

Additionally, the Company informs that, as at the date of this notice, there are assays pending which are currently incomplete and insufficiently definite to warrant disclosure, and for which an announcement is expected shortly, once remaining assays have been received and finalised.
