Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the **"Company")** is pleased to advise that it has issued and allotted 312,500 fully paid ordinary shares ("**Shares**") upon the exercise of 312,500 unquoted options exercisable at \$0.02 per option on or before 18 May 2022. The option conversions raised \$6,250 before costs.
