#### **Cleansing Notice / Appendix 2A**

#### Issue of Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

**Los Cerros Limited (ASX: LCL) ("Los Cerros"** or the **"Company")** advises that it has issued and allotted 1,293,935 fully paid ordinary shares ("**Shares**") upon the exercise of 158,571 unquoted options exercisable at \$0.07 per option on or before 1 July 2025, the exercise of 625,000 unquoted options exercisable at \$0.10 per option on or before 6 April 2022, the exercise of 500,000 unquoted options exercisable at \$0.02 per option on or before 18 May 2022, and the exercise of 10,364 quoted options exercisable at \$0.16 per option on or before 16 August 2021.
