### Cleansing Notice / Appendix 2A

#### Issue of Placement Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

**Los Cerros Limited (ASX: LCL) ("Los Cerros"** or the **"Company")** advises that it has issued and allotted a total of 86,932,750 fully paid ordinary shares ("**Shares**") at \$0.115 per share, under the Placement to sophisticated investors as announced on 15 September 2020. A total of 50,439,655 shares have been issued under Listing Rule 7.1 and a total of 36,493,095 shares have been issued under Listing Rule 7.1A.
