Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the **"Company")** is pleased to advise that it has issued and allotted 17,000,041 fully paid ordinary shares ("**Shares**") upon the exercise of 17,000,0000 unquoted options exercisable at \$0.02 per option on or before 18 May 2022 and 41 unquoted options exercisable at \$0.44 per options on or before 1 June 2020. The option conversions raised \$340,018 before costs.
