Cleansing Notice / Appendix 2A

Issue of Placement Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the **"Company")** is pleased to advise that it has issued and allotted 38,000,000 fully paid ordinary shares ("**Placement**" shares) at \$0.04 per share, under Tranche 2 of the Placement to sophisticated investors as announced on 13 July 2020 and approved by Shareholders at the General Meeting held on 27 August 2020. The Placement shares have been issued under Listing Rule 7.1.

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the shares issued pursuant to the Placement ("**Shares**") and noted in the attached Appendix 2A will fall within the exemption in section 708A(5) of the Act.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Corporations Act"), the Company gives notice that:

- (a) the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
- (b) as at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and section 674 of the Corporations Act; and
- (c) As at the date of this notice there is no information:
 - i. that has been excluded from a continuous disclosure notice in accordance with the Listing Rules other than the update to a previous announcement on 13 August 2020 outlined below; and
 - ii. that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
 - 1. The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - 2. The rights and liabilities attaching to the Securities.

Directors Long Term Incentives

The Company announced on 13 August 2020 that the Board had resolved, subject to shareholder approval, to issue Long Term Incentives (LTI) to directors and key management. The offer to Managing Director Jason Stirbinskis comprised a Tranche 1 milestone hurdle set at achieving a share price greater than \$0.15 which was approximately double the 20-day VWAP on the day of the Board resolution. Tranche 2 and Tranche 3 milestones were set at \$0.20 and \$0.25 being 166% and 233% premium respectively to the 20-day VWAP.

Based on advice received subsequent to that announcement, and to better align comparable LTI offers to each director, the Board subsequently resolved that Performance Rights, rather than Options, are the most appropriate form of incentive for Non-executive directors Ross Ashton and Kevin Wilson. An additional vesting condition has also been included to each Tranche in the event that strong share price performance between the date of the Board resolution and the date of shareholder approval results in the above mentioned hurdles already being met.

As a consequence the Performance Rights offered to Managing Director Jason Stirbinskis remain the same, totalling 9 million in three Tranches. The quantum of Rights offered to Non-executive directors Ross Ashton and Kevin Wilson remain the same as advised on 13 August 2020, namely 2.98 million and 1.98 million respectively, however these will be issued as Performance Rights instead of Options with the same hurdles as for Mr Stirbinskis. Full details of the LTI offers will be disclosed in the Notice of Meeting scheduled for late September 2019.
