Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the "Company") is pleased to advise that it has issued and allotted 937,500 fully paid ordinary shares ("Shares") upon the exercise of 937,500 unquoted options exercisable at \$0.02 per option on or before 18 May 2022. The option conversion raised \$18,750 before costs.

The Company also advises that it has issued and allotted 11,140,778 fully paid ordinary shares ("Shares") to Hongkong Ausino Investments Limited at a price of \$0.0525 per share, pursuant to a purchase order under the terms of the Service and Subscription Agreement between Los Cerros Limited, Miraflores Campania Minera S.A. and Hongkong Ausino Investments Limited.
