Cleansing Notice / Appendix 2A

Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the "Company") is pleased to advise that it has issued and allotted 937,500 fully paid ordinary shares ("Shares") upon the exercise of 937,500 unquoted options exercisable at \$0.02 per option on or before 18 May 2022. The option conversion raised \$18,750 before costs.

The Company also advises that it has issued and allotted 11,140,778 fully paid ordinary shares ("Shares") to Hongkong Ausino Investments Limited at a price of \$0.0525 per share, pursuant to a purchase order under the terms of the Service and Subscription Agreement between Los Cerros Limited, Miraflores Campania Minera S.A. and Hongkong Ausino Investments Limited.

Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the shares issued pursuant to the exercise of options and issue of shares to Hongkong Ausino Investments Limited ("Shares") and noted in the attached Appendix 2A, will fall within the exemption in section 708A(5) of the Act.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Corporations Act"), the Company gives notice that:

- (a) the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
- (b) as at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and section 674 of the Corporations Act; and
- (c) As at the date of this notice there is no information:
  - i. that has been excluded from a continuous disclosure notice in accordance with the Listing Rules; and
