Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the **"Company")** is pleased to advise that it has issued and allotted 10,125,000 fully paid ordinary shares ("**Placement**" shares) under Listing Rule 7.1 as part two of the first tranche of the placement to sophisticated investors as announced to the market on 5 February 2020.
