Issue of Placement Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the "Company") is pleased to advise that it has issued and allotted a total of 750,000 fully paid ordinary shares ("Placement" shares) at \$0.04 per share, under part 2 of Tranche 2 of the Placement to sophisticated investors as announced on 13 July 2020 and approved by Shareholders at the General Meeting held on 27 August 2020. A total of 38,750,000 Tranche 2 Placement shares have been issued under Listing Rules 7.1 and 10.11.

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act.  - 2. The rights and liabilities attaching to the Securities.
